WEATHER POLICY: Glen Rose Market is not responsible for adverse weather conditions, so there are NO REFUNDS FOR THIS REASON. The event will operate in varying weather conditions, and artists must be prepared for adverse weather. Depending on the severity of the weather forecast, the City of Glen Rose reserves the right to delay the event opening, close early, cancel the event, or postpone to another date for the safety of all involved. If any Glen Rose Market is delayed, canceled, or postponed due to weather, all artists will be notified via email with as much advanced notice as possible. We understand the time, effort and money required to participate in an event such as the Glen Rose Market and greatly appreciate your commitment. All decisions will be made considering the substantial investments made by participating artists, food vendors, sponsors, entertainers, venues, and volunteers. Please keep your phone or other devices charged and handy so that you can monitor your email beginning 72 hours before the Glen Rose Market and during the event.
